

DETAILS OF HOURO LUCKY DRAW :

- **No. OF DRAWS** : 1 DRAW EVERY MONTH, TOTAL 10 DRAWS
(7 WINNERS IN EVERY DRAW , TOTAL 70 WINNERS)
- **DRAW DATE** : 26 OF EVERY MONTH
- **DRAW TIME** : 1 PM

RULES & REGULATION :

- EVERY MEMBER SHOULD SUBMIT XEROX COPY OF THEIR AADHAR CARD AND A PASSPORT SIZE PHOTO.
- EVERY MEMBER SHOULD CONTRIBUTE Rs. 10,000/ (MONTHLY LOTTERY AMOUNT) TILL THE 10TH MONTH WITHOUT FAIL.
- MEMBERS SHOULD CLEAR UP THEIR MONTHLY CONTRIBUTION AMOUNT 3 DAYS AHEAD OF THE DRAW WITHOUT FAIL.
- IF A MEMBER WINS A LUCKY DRAW PRIZE WITHOUT CLEARING MONTHLY CONTRIBUTION, PRIZE WILL NOT BE GIVEN TO THE MEMBER . HOWEVER, THE COMMITTEE WILL REFUND HIS/HER CONTRIBUTED AMOUNT ONLY.
- ONCE A MEMBER WINS A PRIZE HE/SHE WILL NOT HAVE TO CONTRIBUTE FURTHER (STOP PAYMENT).
- CONSOLATION PRIZE WILL BE GIVEN TO EVERY MEMBER WHO HAVE NOT WON ANY PRIZE IN THE LUCKY DRAW.
- CONSOLATION PRIZE WILL BE EITHER OF :
